### Beachwalk BOD Meeting Minutes – February 13, 2018

Bill Bryan called the meeting to order at 5:00 PM at the Beachwalk Clubhouse.

Bill asked for approval of January 2018 meeting minutes. Motion was made/seconded to approve and passed unanimously.

### **Committee Reports**

Architectural Control Committee: Bill reported that the ACC had a request from James & Jessica Phillips on 1-23-2018 for replacing exterior siding. It was approved 2-13-2018.

Communications Committee: Bill reported that the web site will offer to Beachwalk HOA an opportunity to "opt-in" to publish/post directory (contact) information. This info would only be available on the secured area of the site.

Facilities/Maintenance Committee: Joe Truelove reported that the clubhouse AC cooling coil had to be replaced. Parts under warranty and labor at \$593. Also, North entrance lighting fixtures (East side of Settlers Ave.) need replacing (not operable at present). Joe will obtain estimates for BOD consideration. South entrance water fountain is under repair from freezing weather damage. Lastly, pool lounge chairs will be picked up for re-strapping.

Financial Committee: Mike Wood highlighted the financial report (see attachment #1). A motion was made/seconded to accept the financials as read. The motion passed unanimously.

Landscape Committee: Gail Morris reported that the meeting between LandCare and Beachwalk HOA took place Saturday, February 10, 2018 at 10:00AM at the clubhouse with a walk-through following. Several residents remarked that the meeting seemed fruitful. She also said additional pruning of Oleanders and Crepe Myrtles is scheduled with leaf removal/cleanup and other services. We remain on winter schedule.

Social Committee: Kate had nothing new to report.

Stormwater Committee: No new issues were reported.

Unfinished Business: Swimming pool lighting deficiency is still pending (Mike & Megan). Tennis court restoration & Pickleball conversion is still pending (George). BOD approved the "self-funded" project 3 to 1. Pre-paying web site hosting charge (long term) was discussed and decided to leave "as-is". Repair of the mailbox toggle switch enclosure was discussed and decided to leave "as-is".
