Post meeting, the directors met in executive session to assign our respective roles. They are as follows:

maintenance project involving several pipes. The Town will include these projects in their FY 2024-2025 Public Works budget. This project is projected to exceed \$130,000 and will be fully funded by the Town. Working with TOKB and Public Works, Tracy will provide updates as they become available.
